### Fuel Subsidy Removal and Consumer Spending Patterns in Etsako-West LGA

#### Abstract

This study examines the effect of fuel subsidy removal on consumer spending patterns in Etsako-west local government area of Edo state in perspective. The subsidiary objectives are to assess how factors such as fuel subsidy removal (FSR), consumer coping mechanisms (CCM), perceptions (CPR), adoption of alternative energy and transportation (AET), and inflation (INF) influence spending behaviour. A quantitative approach was used, with data collected using Likert-scale questionnaires administered across the region. Ordinal regression was employed for data analysis. Model fitting results showed that the full model significantly improved over the intercept-only model (Chi-square = 138.806, p < 0.001), with Pseudo R-square values (Cox & Snell = 0.431; Nagelkerke = 0.448) indicating moderate predictive power. The deviance goodness-of-fit test was satisfactory (p = 1.000), although the test of parallel lines was significant (p = 0.000), suggesting a violation of the proportional odds assumption. Among the predictors, only AET ( $\beta$  = 2.272, p = 0.000) and INF ( $\beta$  = 1.209, p = 0.000) were significant, indicating that inflation and the shift to alternative energy sources are key drivers of changes in spending patterns. FSR, CCM, and CPR were not statistically significant. The study concludes that economic constraints, not awareness or perception, drive consumer adjustment. It recommends government intervention to curb inflation and invest in accessible alternative energy and transport infrastructure. Future studies should explore income level as a moderating factor and consider alternative models for more robust analysis.

### Introduction

Fuel subsidies, though intended to make energy affordable, impose heavy fiscal and social costs (Ovaga & Okechukwu, 2022). Global subsidy spending rose to \$1 trillion in 2022, exceeding aid allocations (International Energy Agency, 2022), with critics urging redirection to development (Couharde & Mouhoud, 2020; Ozili & Ozen, 2021). In Nigeria, subsidies introduced in the 1970s persisted despite failed removals in 1986 and 2012; by 2022, they consumed №4 trillion (23% of the budget), leading to their withdrawal in June 2023. While some studies highlight environmental benefits (Adekunle & Oseni, 2021; Asare et al., 2020), others stress corruption and economic instability (Omotosho, 2020; Umeji & Eleanya, 2021). The 2023 removal, lacking cushioning measures, caused fuel price hikes, inflation, and reduced household spending (Smith, 2016, as cited in Nwachukwu, 2023). Fuel subsidy removal (FSR) in

Nigeria has fueled inflation, reduced savings, and weakened SMEs, prompting coping strategies like carpooling (Francis & Lucas, 2023), and adoption of alternative energy e.g electric vehicles, solar powered electricity instead of fuel or diesel generators, etc.

#### **Statement of the Problem**

In Etsako-West Local government area, rising fuel costs strain households and businesses, cutting essential spending and deepening inequality. Despite its goal of fiscal stability, little research explores its local impact; this study examines how subsidy removal affects consumer spending patterns in the Etsako-west local government area.

### **Research Objectives:**

The main objective of this research is to: examine the effect of fuel subsidy removal (FSR) on consumer spending patterns (CSP) in Etsako-west Local Government Area in perspective.

### Specific objectives are to:

- i. determine the effect of consumer coping mechanisms (CCM) on consumer spending patterns (CSP) following fuel subsidy removal in Etsako-west Local Government Area.
- ii. assess the effect of consumer perceptions of fuel subsidy removal (CPR) on consumer spending patterns (CSP) in Etsako-west Local Government Area.
- iii. analyze how shifts to alternative energy sources and transportation (AET) affect consumer spending patterns (CSP) in Etsakowest Local Government Area.
- iv. evaluate the effect of inflation (INF) on consumer spending patterns (CSP) in response to fuel subsidy removal (FSR) in Etsako-west Local Government Area.

Based on the objectives provided, the researcher hereby posits the following hypotheses:

**H**<sub>01</sub>: Fuel subsidy removal has no significant effect on consumer spending patterns in Etsako-West Local government area in of Edo state in perspective.

Ho2 Consumer coping mechanisms (CCM) have no significant effect on consumer spending patterns
(CSP) in Etsako-west Local Government Area.
Ho3: Consumer perceptions of fuel subsidy removal
(CFR) do not significantly affect consumer spending

patterns (CSP) in Etsako-west Local Government Area. **H**<sub>04</sub>: Shifts to alternative energy sources and transportation (AET) have no significant effect on consumer spending patterns (CSP) in Etsako-west Local Government Area.

Hos: Inflation (INF) has no significant effect on consumer spending patterns (CSP) in Etsako-west Local Government Area.

# **Review of Related Literature**

Concept of Subsidy: A subsidy is government financial support that reduces costs through direct payments, tax relief, or price controls to enhance welfare and affordability (Investopedia, 2015; Merriam-Webster, n.d.; Oxford Advanced Learner's Dictionary, n.d.). Subsidies may be direct, lowering prices immediately, or indirect, via regulations and investments (Alozie, 2009; Adebiyi, 2011).

**Concept of Fuel Subsidy:** Fuel subsidy refers to selling petroleum products below production or importation costs, mainly Premium Motor Spirit (PMS) in Nigeria, as a market intervention to reduce public

burdens (Bakare, 2012; Gordon & Suzanne, 2023). These may take financial, labor, or consumption forms (Francis & Lucas, 2023).

### Concept of Fuel Subsidy Removal (FSR):

Fuel subsidy removal is the withdrawal of government interventions that lower fuel costs, often sparking debate over its socio-economic implications (Centre for Public Policy Alternatives, 2012).

## History of Fuel Subsidy Removal from 1973-2023

Since 1973, Nigeria has witnessed repeated subsidy removals and fuel price hikes under successive regimes, culminating in Tinubu's 2023 policy that raised prices to over N600 per litre (NNPC, 2024). The success of such reforms depends on phased implementation, transparency, and public trust, as poorly managed removals have fuelled protests, inequality, and corruption (CSEA, 2010; World Bank, 2010; Ikpeze et al., 2004). Nonetheless, potential benefits include fiscal savings for infrastructure and social services, as well as competition and investment in the petroleum sector (Oluwabukola, 2023; Civic Keypoint, 2023).

# Fuel Subsidy Removal (FSR) and Consumer Spending Patterns (CSP):

Subsidy removal has reshaped consumption, particularly among low-income earners. Rising fuel and energy costs have encouraged shifts toward bicycles, electric vehicles, solar power, and compressed natural gas (Statista, 2024; Nwohu et al., 2023; Mutsaka, 2023).

### **Consumer Coping Mechanisms**

Coping mechanisms include income diversification, cost-cutting, and carpooling, though these disproportionately burden poor households (Algorani & Gupta, 2022; Orluchukwu & ThankGod, 2024).

# Fuel Subsidy Removal (FSR) and its effect on Inflation:

The policy has fuelled sharp inflation, reducing purchasing power and consumption expenditure, while increasing transport and production costs (Al-Awlaqi et al., 2018; Mohammed et al., 2020; Houeland, 2020; Ozili & Obiora, 2023). Although demand for petrol has declined, reliance on global oil prices suggests continued high costs, pushing consumers toward renewable alternatives (Raji, 2018).

# **Consumer Perceptions:**

In areas like Etsako-West Local Government Area, consumers largely view subsidy removal as unfair and elite-driven, reflecting distrust in government and concerns over poor reinvestment of savings (Okereke et al., 2024). Households report significant erosion of purchasing power, forcing spending shifts toward

essentials (Salihu, 2023). Scepticisms persists regarding alternatives like CNG due to poor infrastructure (Mutsaka, 2023), while regional perspectives frame the

policy as deepening economic injustice in oil-producing communities (Meludu et al., 2024).

Based on the data above, PMS consumption increased steadily from January to March 2023 due to economic activities and anticipated price changes, rising from 62.31 to 72.39 million litres. Demand stabilized from April to May, with minimal fluctuations, indicating market balance. However, subsidy removal in June led to a sharp decline (\$\frac{1}{2}8.33\%), followed by a further drop in July (\$\frac{1}{2}8.77\%) as consumers adjusted by reducing fuel usage. This decline impacts transportation, logistics, and overall economic activity. Policy interventions, such as public transport subsidies, could help stabilize consumption. The shift in consumer behaviour suggests a long-term reduction in fuel use unless prices are moderated.

# **Concept of Consumer Spending Patterns (CSP):**

CSP refers to household purchasing behaviours shaped by income, prices, inflation, credit, consumer confidence, technology, and socio-cultural factors (Mankiw, 2019; Kotler & Keller, 2016). As the largest component of aggregate demand (Krugman & Wells, 2018), CSP shifts with economic cycles and social trends. Classical theories like Keynes' Absolute Income Hypothesis (1936) and Friedman's Permanent Income Hypothesis (1957) explain consumption behaviour relative to income levels.

# **Factors Influencing Consumer Spending Patterns ( CSP):**

Income determines consumption capacity (Case et al., 2020), while inflation reduces purchasing power and prioritizes essentials (Blanchard, 2021). Consumer confidence influences saving vs. spending (Deaton, 1992). Credit access stimulates but may later restrain consumption (Mishkin, 2016). Technology fosters online and impulse spending (Laudon & Traver, 2021), and socio-cultural shifts drive trends like eco-friendly purchases (Solomon, 2018).

### **CSP and Fuel Subsidy Removal (FSR):**

Subsidy removal raises costs of fuel, transport, and goods, driving inflation and forcing households to prioritize basics over discretionary spending (World Bank, 2023; NBS, 2024; IMF, 2023). In Nigeria, the 2023 removal reduced purchasing power, triggered poverty, and shifted behaviour toward survival-focused consumption (World Bank, 2023).

#### **Theoretical Framework:**

Consumer Behaviour Theory (CBT) explains how price changes lead consumers to prioritize essentials, cut non-essentials, and seek alternatives (Howard & Sheth, 1969; Kotler & Keller, 2016). Rational Choice Theory (RCT) emphasizes cost—benefit decisions to maximize utility (Becker, 1976; Elster, 1989). This study adopts CBT for its focus on consumer responses to price shifts.

# **Empirical Review:**

Studies show subsidy removal alters energy and transport choices, with households shifting to cheaper alternatives (Obinna, 2020; Lin & Kuang, 2020; Harring et al., 2023). In Nigeria, rising fuel prices increased reliance on public transport and ride-sharing (Akpan & Uford, 2024), while inflation eroded savings and widened inequality (Ogboru & Akinyotu, 2024; Abd Obaida et al., 2020). Evidence supports the inclusion of Alternative Energy & Transportation Shifts (AET) and Inflation Impact (INF) as key determinants of CSP post-FSR.

### Methodology

This study adopted a descriptive survey design to examine the effects of fuel subsidy removal on consumer spending patterns in Etsako-west LGA. The population was 294,000 (NPC, 2022), and a sample size of 246 was determined using Freund and Williams' formula (1967) with parameters: P = 0.8, Q = 0.2, Z =

1.96, and e = 0.05 (Agbadudu, 2004). A pilot test 100 questionnaires (test-retest method) confirmed P = 0.8 and Q = 0.2. Respondents were selected via random sampling across towns and villages. Data were collected using a 5-point Likert questionnaire, and

analyzed with descriptive statistics (mean, SD) and ordinal regression, with hypotheses tested at p< 0.05. This approach ensured reliable assessment of subsidy removal's impact on consumer spending in the area.

# Descriptive Analysis of FSR, CCM, AET, INF, and CSP

**Fuel Subsidy Removal (FSR):** Findings show near-unanimous agreement that FSR raised transport costs, prices of essentials, and household expenses, with 100% confirming transport hikes and over 97%

acknowledging higher living costs. Mean responses (49.2) and SDs (99.87–105.1) confirm significant impact, highlighting need for policy support (World Bank, 2023). **Consumer Coping Mechanisms (CCM):** About 96% reduced non-essential spending, 99% shifted to cheaper transport, and 95% revised budgets,

indicating widespread behavioural adjustments to rising costs (NBS, 2024).

Consumer Perception (CPR): Public opinion remains divided—41% see FSR as necessary for growth, 29% disagree, and 53% oppose government's decision. Yet 95% believe negative effects outweigh benefits, underscoring dissatisfaction and demand for mitigating policies (IMF, 2023).

Alternative Energy & Transport (AET): Many respondents consider solar power and electric vehicles as alternatives, signaling readiness for sustainable energy shifts, though affordability and infrastructure remain barriers (Harring et al., 2023).

**Inflation Impact (INF):** High inflation eroded purchasing power, curtailed access to essentials, and reduced savings/investments, worsening financial strain (Blanchard, 2021).

Consumer Spending Patterns (CSP): Rising fuel costs reduced savings, lowered purchasing power, and forced cutbacks even on essentials, reflecting declining financial stability in affected households (Akpan & Uford, 2024).

# **Demographic Analysis of the Respondents**

The gender distribution analysis of respondents in Etsako-west local government area shows that 52.8% were female and 47.2% were male, indicating a slightly higher female participation. This suggests that women, who often manage household expenses, are more directly affected by rising costs due to fuel subsidy removal. Women may experience financial strain in budgeting for food, transportation, and healthcare, while men, especially in business and transport sectors,

may face income challenges due to increased operational costs. This highlights the need for gender-sensitive policies, such as transport subsidies for market women and financial support for male-dominated industries. Overall, both genders feel the impact, but women may bear a greater financial burden, necessitating targeted economic interventions to mitigate the effects of subsidy removal.

The analysis of monthly household income in the study indicates that 57.3% of respondents earn less than №50,000 per month, showing that the majority of households in Etsako-west local government are in the low-income category. Another 13.8% earn between №50,000 and №100,000, bringing the total percentage of respondents earning below №100,000 to 71.1%. This suggests that a significant portion of the population struggles with financial constraints, especially in light of fuel subsidy removal and rising costs. Only 28.9% of

respondents earn above №100,000, with 8.9% earning over №500,000. This small percentage of higher-income households suggests that a minority can absorb the economic shocks caused by subsidy removal. Given that most households have low earnings, the impact of fuel subsidy removal is likely severe, leading to reduced purchasing power, increased cost of living, and possible changes in spending patterns. Government interventions such as wage adjustments, price control policies, and social assistance

programs may be necessary to support low-income earners.

The analysis of means of transportation among respondents reveals diverse commuting patterns in Etsako-west local government area. The most commonly used mode of transportation is motorbikes/tricycles, with 66 respondents (26.8%) relying on them. This suggests that these informal transport options play a significant role in mobility, possibly due to affordability and accessibility, especially in areas with poor road infrastructure. Public transportation follows closely, accounting for 26.4% (65 respondents). This highlights the reliance on buses and taxis for daily commuting, which may be influenced by fuel prices and public transport

availability. Walking or cycling is another significant mode, with 62 respondents (25.2%), indicating that a substantial portion of the population either prefers non-motorized transport or has limited access to motorized alternatives. Private vehicle ownership is the least common, with 53 respondents (21.5%) using their own cars. This relatively low figure suggests that the high cost of fuel and vehicle maintenance might be discouraging private car use. The findings align with the economic constraints affecting consumer spending patterns, as rising transportation costs could force individuals to adopt more cost-effective means of travel.

### a. Lilliefors Significance Correction

All the four CSP variables significantly deviate from normality. This is because all the p-values (Sig.) are less than 0.05, leading to rejection of the null hypothesis for both tests. Therefore, the data is not normally distributed for any of the variables. This

implies that a non-parametric test will be appropriate for the analysis. It is therefore expedient for the researcher to apply ordinal regression which is also called ordinal logistic regression or PLUM in SPSS since it does not require normality of the independent or dependent variables.

predictors are not constant across categories of CSP.

Intercept Only -2 Log Likelihood = 504.405, this is the baseline model with no independent variables. It represents how well we can predict the dependent variable using only the average tendency (intercept). A higher -2LL value means poor fit — this model does not explain much. Final Model -2 Log Likelihood = 365.599, this model includes your predictors (independent variables — possibly CSP1 to CSP4). The sharp drop in the -2Loglikelihood value from 504.405 to 365.599 shows that: Adding the predictors has significantly improved the model's explanatory power. Chi-Square = 138.806 with df = 5, Sig. = 0.000. This

tests whether the final model is significantly better than the null model. Since p=0.000, this is highly significant. **Interpretation**: There is strong evidence that at least one of your predictors significantly influences the dependent variable. We can reject the null hypothesis that "the predictors have no effect. The ordinal regression model significantly fits the data better than a model with no predictors. This means the independent variables (e.g., CSP1–CSP4) do help explain changes in the dependent variable (Likert-scale based), and the model is statistically valid for interpretation.

**Pearson Chi-Square**: Chi-Square = 937.117, df = 418, Sig. = 0.000. This result tests whether the observed responses match what the model predicts. Because p = 0.000 (less than 0.05): It suggests a poor fit — that is, the model's predictions don't perfectly match the data. **Deviance Chi-Square**: Chi-Square = 305.182, df = 418, Sig. = 1.000. This is a better indicator of model fit in

ordinal regression, p=1.000 (greater than 0.05), this means the model fits the data well — the predicted responses are consistent with what was actually observed. This is the result that should be trusted when there is a conflict. Although the Pearson test flags a problem, the Deviance test confirms that the model is a good fit for the data.

Cox and Snell R<sup>2</sup> = 0.431 Suggests the model explains 43.1% of the variation in the dependent variable. Nagelkerke R<sup>2</sup> = 0.448, this adjusts Cox & Snell so that the maximum value can be 1.0. The model explains about

44.8% of the variation in the dependent variable (CSP), which is moderately strong. McFadden R<sup>2</sup> = 0.171 suggests acceptable model performance.

Based on the table above, the key predictors shows that AET (statistically significant): Consumers shifting to alternative energy/transport strongly influences spending pattern. INF (statistically significant): Inflation has a powerful, direct influence on how consumers adjust their spending. Other variables (FSR, CCM, CPR) are statistically insignificant in this model context.

Fuel Subsidy Removal's Impact is Indirect, Not Direct. While fuel subsidy removal (FSR) is a critical economic policy change, the results indicate that its effect on consumer spending is not direct but rather manifests through other factors. The increase in fuel prices caused by subsidy removal has forced consumers to adapt in specific ways, primarily through changes in energy consumption and transportation choices (AET) and adjustments to inflation-induced price increases (INF). Shift to Alternative Energy and Transportation (AET) Captures Behavioural Adjustments. Rising fuel costs have compelled consumers to modify their spending

patterns by seeking alternatives such as public transportation, carpooling, or renewable energy sources for household and business use. This aligns with the study's objective of identifying how consumers adjust their spending priorities in response to policy-induced economic shocks. The removal of fuel subsidies has contributed to higher inflation, leading to an increase in the prices of goods, services, and overall cost of living. Since inflation reduces purchasing power, consumers are forced to reallocate spending, impacting their consumption habits across various sectors. The statistical significance of INF confirms that rising costs are a dominant factor shaping consumer spending decisions in the post-subsidy period.

# **Discussion of Findings**

The findings of this study provide empirical support for the arguments and conclusions drawn by prior researchers regarding the impact of fuel subsidy removal on consumer spending patterns.

FSR (Fuel Subsidy Removal), CCM (Consumer Coping Mechanisms), and CPR (Consumer Perception of Fuel Subsidy Removal) from the study, were not statistically significant in influencing consumer spending patterns (CSP). Only AET and INF are the strongest and most reliable predictors, improving the explanatory power and robustness. The significant p-values (0.000) for AET and INF confirm that these variables have a strong, and have systematic effect on Consumer spending patterns (CSP).

Alternative Energy & Transportation Shift (AET) and Consumer Spending Patterns. The study reveals a strong positive relationship between shifts to alternative energy sources and transportation (AET) and consumer spending patterns. This finding is consistent with the work of Harring et al. (2023), who highlighted that socio-economic factors influence attitudes subsidy removal during towards energy transitions. Similarly, Lin and Kuang (2020) demonstrated that energy subsidy removal in China led to increased energy costs, forcing lowincome households to adjust consumption behaviours. The significant effect of AET in the revised model underscores how Nigerian households and businesses are altering their spending priorities by adopting alternative energy sources e.g. fuel powered generators to solar powered electricity, fuel powered vehicles to Compressed Natural Gas (CNG) powered vehicles, and modifying transportation habits in response to rising fuel prices.

Impact of Inflation (INF) on Consumer Spending Patterns

The study also establishes that inflation has a statistically significant impact on consumer spending patterns. This aligns with Ogboru and Akinyotu (2024), who found that rising fuel prices reduce household purchasing power, leading to lower savings, limited access to

essential services, and increased poverty, particularly among vulnerable groups. Similarly, Akpan and Uford (2024) confirmed that inflationary pressures stemming from fuel price increases elevate the costs of consumer goods and services, affecting overall spending behaviour. The strong relationship observed in this study between inflation and consumer spending suggests that as prices rise, consumers are forced to prioritize essential goods while cutting back on discretionary expenditures, which mirrors findings in previous research.

### Broader Economic and Social Implications

The study's findings reinforce Obinna (2020), who demonstrated that fuel subsidy removal in Maiduguri negatively impacted household livelihoods, with family size, dependency ratios, and education levels influencing the extent of the impact. The current study corroborates these observations by showing that inflationary pressures and shifts in energy use significantly reshape household financial decisions. Furthermore, Abd Obaida et al. (2020) explored how subsidy removal affects tax compliance behaviour among SMEs, which aligns with the present study's suggestion that businesses are experiencing operational cost increases, leading to changes in their financial planning and expenditure patterns. The findings of this study are in line with existing literature, reinforcing the argument that fuel subsidy removal significantly alters consumer spending behaviour through inflationary pressures and shifts in energy and transportation usage. These results confirm that Nigerian households and businesses adapting by prioritizing expenditures, seeking alternative energy sources, and making adjustments to transportation choices to mitigate rising costs.

# Conclusions and Recommendations Conclusions

This study examined the impact of fuel subsidy removal on consumer spending patterns in Etsako-west local government of Edo state, Nigeria. The findings revealed that AET and INF significantly influence consumer spending behaviour, confirming previous studies that highlighted the economic strain caused by fuel price fluctuations and inflationary pressures. The results indicate that rising fuel costs drive consumers to seek alternative energy sources and modify their transportation choices, which in turn affects overall expenditure patterns. Furthermore, inflation exacerbates the financial burden on consumers, leading to reduced discretionary spending and altered consumption behaviour.

The study thus aligns with existing literature, which underscores the adverse effects of subsidy removal on low-income households, small businesses, and economic stability. The revised model effectively captures the essential drivers of consumer spending shifts in response to subsidy removal, emphasizing the need for targeted economic policies that mitigate these adverse effects.

#### Recommendations

Based on the study's findings, the following recommendations are hereby proposed:

- 1. Government Policy Intervention:
  Policymakers should implement cushioning mechanisms such as targeted subsidies for essential commodities, transportation support, and incentives for alternative energy adoption to reduce the economic burden on consumers.
- 2. Investment in Alternative Energy Sources: The government and private sector should invest in affordable and sustainable energy solutions, such as solar and compressed natural gas (CNG), to provide cost-effective alternatives to fuel-dependent transportation and household energy needs.

- 3. Monetary and Fiscal Policy Adjustments: Inflation control measures, such as stabilizing the exchange rate and reducing import duties on essential goods, should be prioritized to minimize inflationary pressures on consumer spending.
- 4. Consumer Awareness and Adaptation Strategies: Public awareness campaigns should be initiated to educate consumers on cost-saving measures, energy-efficient alternatives, and strategic financial planning in response to changing economic conditions.
- 5. Support for Small and Medium Enterprises (SMEs): Special financial aid programs, tax incentives, and low-interest credit facilities should be provided to SMEs to help them cope with rising operational costs due to subsidy removal.
- 6. Further Research: Additional studies should explore the long-term implications of subsidy removal on economic growth, household welfare, and business sustainability, considering regional variations and evolving policy landscapes.

These recommendations, if implemented, will help mitigate the adverse effects of fuel subsidy removal, promote economic stability, and support consumer resilience in Nigeria's dynamic economic environment.
