Green Management Practices and Environmental Sustainability in Selected Universities in South-East Nigeria

Abstract

This study examined the impact of green management practices on environmental sustainability in selected universities in South-East Nigeria. The study was guided by three key dimensions of green management: recycling and waste reduction, green knowledge acquisition, and green solutions. The research adopted a descriptive survey design, with data collected from 370 respondents comprising staff and students across five selected universities in the south south region of Nigeria. A structured questionnaire was employed, and data were analyzed using descriptive statistics, Pearson correlation, and multiple regression analysis. The findings revealed that all three green management practices significantly influenced environmental sustainability, with green solutions and green knowledge acquisition showing the strongest effects. Although some practices were inconsistently implemented across institutions, the overall model showed that green management practices accounted for 62% of the variation in sustainability outcomes. These results align with Institutional Theory and Systems Theory, highlighting that external pressures and system-wide coordination are crucial to institutional sustainability. The study concludes that effective implementation of green policies, investment in eco-technology, and environmental education are vital strategies for promoting sustainability in higher education. Recommendations include policy reforms, stakeholder training, investment in green infrastructure, and performance monitoring. This research contributes to existing body of knowledge on environmental management within Nigerian tertiary institutions and provides a framework for integrating sustainable practices into campus operations.

Introduction

The global shift toward sustainable development has increasingly placed pressure on institutions, including universities, to implement environmentally responsible practices. Higher education institutions are not only centers of learning and innovation but also powerful agents for promoting ecological consciousness and long-term environmental sustainability (Adeniran et al., 2023). In response to global climate challenges and the United Nations Sustainable Development Goals (SDGs), especially Goal 13 (Climate Action) and Goal 4 (Quality Education), universities worldwide are adopting green management practices to minimize their ecological footprint and lead by example.

In Nigeria, the integration of sustainability principles into university operations is gradually gaining momentum, though progress remains uneven across regions. Green management involves the implementation of policies and actions such as energy conservation, waste reduction, eco-friendly infrastructure, renewable energy use, and environmental education to promote sustainability

(Okorie & Akpan, 2024). While some universities in Nigeria's urban centers have made commendable strides in this area, those in the South-East region are still grappling with several institutional, infrastructural, and financial barriers that hinder full implementation (Ezeokoli et al., 2022).

The South-East region of Nigeria, comprising states such as Enugu, Anambra, Imo, Ebonyi, and Abia, hosts several prominent universities—including the University of Nigeria, Nsukka (UNN); Nnamdi Azikiwe University (UNIZIK); Federal University of Technology, Owerri (FUTO); and Ebonyi State These University (EBSU). institutions demonstrated varying levels of commitment to green campus development through initiatives such as solar-powered lighting, student-led recycling projects, and research in environmental science (Ilo et al., 2023). However, these efforts often remain fragmented and unsystematic due to the absence of formal environmental management frameworks and a lack of government policy enforcement (Nnaji & Ibe, 2025).

Post-COVID-19 realities have further emphasized the importance of sustainability in university systems, as institutions now face increased energy demands for hybrid learning environments, rising utility costs, and health-driven requirements for better campus sanitation and waste disposal (Obi et al., 2023). This emerging context necessitates a comprehensive exploration of how universities in South-East Nigeria are managing environmental sustainability and what challenges and opportunities lie ahead.

Given the strategic role of higher education in shaping environmentally literate graduates and future leaders, a thorough assessment of green management practices in South-East Nigerian universities is timely and essential. It is expected that strengthening green management in these institutions will not only reduce their environmental impact but also serve as a catalyst for regional and national sustainable development.

Statement of Problem

Despite the increasing global emphasis environmental sustainability and the growing recognition of universities as key drivers of sustainable development, many higher institutions in South-East Nigeria continue to struggle with the implementation of effective green management practices. While some universities in the region have initiated solar lighting projects, waste recycling programs, and sustainability-themed research, these efforts are often fragmented, underfunded, and lacking institutional coordination.

Universities in the region still largely depend on diesel-powered generators, lack formalized environmental policies, and operate in environments

are valuable to multiple stakeholders within and outside the academic community.

It will provide a region-specific understanding of how universities can adopt and scale up green initiatives, thereby contributing to academic discourse on environmental sustainability and institutional reform. Universities in South-East Nigeria can use the findings to benchmark their sustainability performance, identify weaknesses in their green management systems, and implement more effective practices. This can lead to cost savings, improved energy efficiency, enhanced global reputation, and compliance with environmental standards. By focusing on green knowledge acquisition, the study will help in shaping eco-conscious behaviours among students and staff. It will advocate for the integration of sustainability into curricula and campus life, helping universities to produce graduates who are environmentally literate and solutions-oriented.

REVIEW OF RELATED LITERATURE **Conceptual Review Concept of Green Management**

Green management refers to the deliberate incorporation of environmentally responsible

where waste is poorly managed, green buildings are rare, and awareness of sustainability issues remains among staff and students. Moreover, infrastructural limitations, inadequate budgetary allocations, and the absence of government-mandated sustainability frameworks continue to hinder the integration of green practices into university operations and curricula.

In the post-COVID-19 era, the need for sustainable infrastructure has become even more critical, with increased pressure on universities to provide clean energy, improve campus hygiene, and support hybrid learning systems. However, without strategic green management approaches, universities in the South-East may fall behind in contributing to the United Nations Sustainable Development Goals (SDGs), with particular reference to Quality Education, Affordable and Clean Energy, and Climate resilience. This study would be guided by the following specific objectives:

- 1. To evaluate the contribution of recycling and waste reduction efforts to sustainable campus operations.
- 2. To assess the level of green knowledge acquisition among students and staff and its influence on environmental sustainability.
- 3. To identify the types of green solutions adopted by universities and analyze This study is significant for several reasons, particularly in the context of growing environmental concerns and the global drive toward sustainable development. examining green management practices in South-East Nigerian universities, the study will generate insights that

practices into organizational policies, operations, and culture with the aim of reducing negative environmental impacts and promoting sustainability. It involves initiatives such as energy conservation, waste reduction, pollution control, and the use of renewable resources to ensure that an institution's activities align with the principles of environmental stewardship (Okoye & Nwankwo, 2024).

In the context of higher education institutions, green emphasizes management the integration sustainability into academic operations, campus resource planning, utilization, and student engagement. Universities that adopt green management strive to minimize their ecological footprint through practices such as proper e-waste paperless administration, disposal, conservation, and the development of eco-friendly infrastructure (Eze, Ogbu & Anene, 2025). These efforts not only improve institutional sustainability environmental performance but also instill consciousness in students and staff.

Adebayo and Ijeoma (2024), stated that green management is multi-dimensional, comprising strategic policies, behavioural change,

technological innovation aimed at fostering longterm ecological balance. Its successful implementation often requires top-level commitment, cross-departmental collaboration, adequate funding, and continuous awareness campaigns. It also aligns with global initiatives such as the United Nations Sustainable Development Goals (SDGs), particularly Goal 13 (Climate Action) and Goal 12 (Responsible Consumption and Production).

Furthermore, green management in universities serves as a model for wider societal transformation, as tertiary institutions are centers for knowledge generation and dissemination. If properly implemented, it has the potential to influence public policy, promote environmental literacy, and drive innovations in sustainable technologies (Onyema & Egbule, 2025).

In recent years, universities are increasingly recognizing their responsibility not only to educate about sustainability but also to embody it in practice. As highlighted by Chukwu and Obasi (2025), institutions that adopt green management practices often experience improved resource efficiency, enhanced institutional reputation, and greater stakeholder engagement. These practices range from simple behaviour changes, such as switching off unused electrical appliances, to more complex interventions like integrating sustainability into curriculum and research agendas.

Moreover, the success of green management in universities hinges on the extent to which environmental values are institutionalized. Umeh and Okafor (2024), posited that embedding sustainability into an institution's mission, governance structures, and performance metrics ensures that green practices are not treated as isolated projects but as integral to the university's operation. This requires proactive leadership, participatory decision-making, and continuous monitoring. In this light, green management becomes not just a technical initiative but a cultural transformation that aligns academic goals with ecological responsibility, positioning the university as a change agent in addressing environmental challenges at the local and global levels.

Recycling and Waste Reduction

Recycling and waste reduction are essential components of green management practices aimed at minimizing the volume of waste sent to landfills, conserving natural resources, and reducing environmental pollution. In university environments, these practices encompass the collection, sorting, processing, and reusing of materials such as paper, plastic, glass, and food waste. They also involve strategies to reduce waste at the source, such as digitalization of administrative tasks, the use of refillable containers, and sustainable procurement policies (Okafor & Ezenwa, 2025). Through effective recycling and waste reduction, institutions can

significantly lower their ecological footprint and contribute to a culture of environmental responsibility.

Many Nigerian universities are increasingly adopting campus-wide recycling initiatives, waste segregation programs, and awareness campaigns to instill sustainable habits among students and staff. For instance, Nnaji and Edeh (2024) report that some universities in South-East Nigeria have implemented "Green Campus" programs that include waste separation bins, composting units, and recycling partnerships with local firms. These initiatives have led to measurable reductions in campus waste volume and improved waste handling efficiency. However, the effectiveness of such programs often depends on stakeholder participation, institutional commitment, and regular monitoring. Without these, recycling systems risk becoming dormant or symbolic rather than impactful.

Moreover, waste reduction practices are not limited to physical waste. The digital transformation of academic and administrative services — such as online exams, paperless communication, and elibrary systems — significantly contributes to reducing paper waste and carbon emissions. As observed by Ibrahim and Okon (2025), universities that prioritize digitization not only reduce operational costs but also enhance environmental sustainability. Waste audits, environmental clubs, and sustainability committees also play critical roles in monitoring progress and driving continuous improvement in waste reduction efforts.

Despite the growing emphasis on recycling in universities, many institutions in South-East Nigeria still face operational challenges such as inadequate waste sorting facilities, lack of clear recycling policies, and poor behavioral compliance among students and staff. As noted by Chinedu and Afolabi (2025), improper waste segregation is a major barrier that reduces the efficiency of recycling programs and increases contamination, thereby making recyclable materials unsuitable for reuse. Additionally, limited institutional investment in waste infrastructure often hampers the long-term success of recycling initiatives. To overcome these challenges, it is essential for universities to integrate recycling goals into their broader sustainability plans and to provide training and incentives that encourage community participation.

Furthermore, successful waste reduction goes beyond infrastructure—it requires a shift in institutional Educational culture. campaigns, student-led sustainability clubs, and reward systems for sustainable practices have proven effective in promoting behavioral change (Ekene & Uche, 2024). By involving students and staff in environmental audits and sustainability decision-making, universities can foster a sense of ownership and accountability. For example, Ebonyi State University has reported a 30% reduction in total campus waste through a combination of composting, material reuse programs, and digital migration of records (Ifeanyi & Musa, 2025). These outcomes highlight the potential for well-structured recycling and waste reduction systems to transform campuses into models of environmental stewardship.

Green Knowledge Acquisition

Green knowledge acquisition refers to the process by which individuals and institutions gain awareness, understanding, and practical competencies related to environmental sustainability. In the context of universities, this includes formal learning through environmental science courses, seminars, and research, as well as informal learning from campus sustainability practices and peer engagement. According to Nwafor and Egwuatu (2024), the minimalism. Additionally, university faculty and staff who are equipped with green knowledge are more likely to support the implementation of green management initiatives and influence institutional policy. Therefore, fostering a knowledgeable academic community is essential for embedding sustainability into university culture.

Moreover, green knowledge acquisition is enhanced through interdisciplinary learning and experiential approaches such as field projects, sustainability audits, and green innovation contests. As highlighted by Bello and Ogu (2024), practical exposure to reallife environmental issues enhances critical thinking and problem-solving, enabling students to apply theoretical knowledge to complex sustainability challenges. When universities invest in green capacity-building programs, they not only increase internal awareness but also produce environmentally conscious graduates who serve as change agents in society.

Despite the growing recognition of its importance, green knowledge acquisition in many Nigerian universities remains insufficiently institutionalized. A study by Chukwu and Ajani (2025) revealed that while some universities offer sustainability-related courses, they are often elective rather than core components of the general curriculum. This limits exposure for students outside environmental disciplines. Furthermore, there is often a disconnect between academic knowledge and practical sustainability efforts on campus, which reduces opportunities for experiential learning. To close this gap, institutions must integrate green education disciplines and develop campus-wide programs that promote hands-on sustainability practices.

Digital platforms and e-learning tools have also emerged as effective channels for promoting environmental awareness and knowledge acquisition. Online sustainability modules, webinars, and virtual campaigns provide flexible and scalable means of educating students and staff about climate action, resource conservation, and sustainable lifestyles

effectiveness of sustainability programs in higher education is strongly linked to the extent of environmental knowledge imparted to students and staff. Green knowledge empowers individuals to adopt sustainable behaviors, make informed decisions, and contribute to institutional and societal environmental goals.

Universities play a crucial role as incubators of environmental literacy by integrating sustainability into curricula, extracurricular activities, and community engagement programs. A study by Okenwa and Ihedioha (2025) found that students who participated in campus-led sustainability workshops and environmental clubs demonstrated a higher likelihood of engaging in eco-friendly behaviors such as recycling, energy conservation, and digital

(Ogundipe & Nwachukwu, 2024). These approaches not only support knowledge dissemination but also foster continuous engagement beyond the classroom. For green knowledge to translate into behavioral change and policy support, it must be reinforced by practical examples, visible leadership, and institutional commitment. According to Adegoke and Nnadi (2024), when students see universities modeling sustainable practices — such as solar power usage, eco-friendly procurement, and waste segregation — it reinforces the lessons learned and encourages long-term sustainable attitudes.

Solutions

Green solutions refer to environmentally friendly strategies, technologies, and practices that aim to mitigate negative environmental impacts and promote sustainable development. In university settings, green solutions are increasingly being adopted to enhance sustainability performance through energy efficiency, eco-friendly construction, sustainable transport systems, water conservation, and renewable energy deployment. According to Eze and Chukwuemeka (2024), green solutions in Nigerian universities are being implemented gradually, often driven by environmental policies, donor-funded projects, or proactive institutional leadership. These initiatives are intended to reduce carbon emissions, minimize waste, and foster a culture of environmental responsibility among students and staff.

One prominent green solution is the use of renewable energy technologies such as solar panels and inverters to power classrooms, administrative buildings, and streetlights. This has become especially relevant in the South-East region, where irregular power supply disrupts academic activities. Okorie and Nwosu (2025) found that universities that adopted solar power systems reported lower energy costs and reduced dependency on diesel-powered generators, thereby cutting greenhouse gas emissions. Other effective green solutions include the integration of rainwater harvesting systems, the

development of green buildings, and the creation of green spaces that contribute to biodiversity conservation and improved campus aesthetics.

Moreover, ICT-based solutions such as cloud computing, digital classrooms, and e-administration significantly reduce paper usage and streamline processes. As highlighted by Abiola and Emeh (2024), the digitalization of administrative functions and learning environments in some Nigerian universities has contributed to notable reductions in resource consumption and environmental degradation. However, the successful adoption of green solutions depends on institutional commitment, adequate funding, stakeholder engagement, and technical capacity. Therefore, universities need to develop strategic sustainability plans that incorporate both short-term and long-term green interventions to enhance environmental performance and institutional resilience.

In addition to energy and water-focused initiatives, some universities in South-East Nigeria are embracing sustainable architectural designs and green building standards to improve energy efficiency and reduce resource wastage. Green buildings incorporate features such as natural ventilation, energy-efficient lighting, recycled materials, and smart water usage systems. As noted by Ibeh and Uzo (2025), campuses that have adopted eco-architecture not only reduce operational costs but also create healthier learning environments that enhance productivity and wellbeing. These physical infrastructures serve as visible commitments to sustainability, reinforcing institutional values and encouraging behavioral alignment among the university community.

Furthermore, collaborative innovation and research in green technology have emerged as powerful tools for advancing campus sustainability. Partnerships between university departments, local industries, and government agencies have led to the development of context-specific green solutions such biodegradable packaging, climate-smart agriculture projects, and low-cost energy-saving devices. According to Nwoke and Adeyemi (2024), these initiatives enable universities to act as living laboratories for sustainable innovation, fostering hands-on learning while addressing environmental challenges in their immediate environments. When these green solutions are embedded within institutional strategy and supported by continuous capacity-building, they significantly contribute to long-term environmental performance and societal impact.

Environmental Sustainability

Environmental sustainability refers to the responsible interaction with the environment to avoid depletion of natural resources, ensuring that the ecological balance is maintained for present and future generations. It involves practices and policies that

reduce environmental degradation, promote conservation, and support the regeneration of natural ecosystems. In the context of higher education, environmental sustainability encompasses how universities manage energy consumption, waste generation, water use, green spaces, and transportation in ways that align with global sustainability goals such as the United Nations' Sustainable Development Goals (SDGs) (Ogbonna & Ezeani, 2024).

Universities have a unique dual role in promoting environmental sustainability: they are significant consumers of resources and influential centers for education, innovation, and behavioral change. As highlighted by Dike and Aluko (2025), higher institutions that embed sustainability into their operations, curriculum, and community outreach efforts contribute significantly to climate action, resource efficiency, and environmental awareness. Environmental sustainability initiatives universities may include renewable energy adoption, tree planting campaigns, e-waste recycling, water harvesting systems, and integration of sustainability topics across academic disciplines.

However, the extent of sustainability adoption varies widely among institutions, often influenced by funding availability, leadership commitment, staff capacity, and stakeholder awareness. As supported by Ezenagu and Okoro (2025), while some Nigerian universities have made significant progress in implementing sustainability programs, others lag due to policy inconsistency, lack of data, and poor institutional engagement. Moreover, long-term sustainability outcomes are often achievable only when environmental values are embedded in the institutional culture through continuous education, transparent governance, and proactive student involvement.

Environmental sustainability is not only a moral and ecological imperative but also a strategic necessity. Universities that prioritize sustainability are more resilient, adaptable to climate risks, and capable of attracting international funding and partnerships. As Umeh and Adebisi (2024) assert, environmentally sustainable universities serve as living laboratories for innovation and as role models for the wider society, reinforcing the need to institutionalize green thinking and practice across all levels of academic operations.

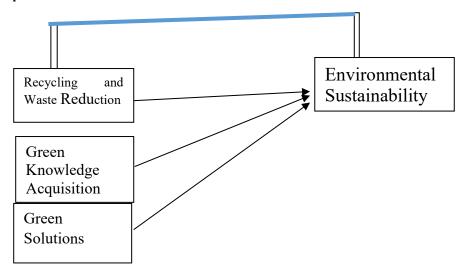
While environmental sustainability initiatives have gained traction globally, many universities in developing countries, including those in South-East Nigeria, still struggle with implementation due to financial limitations and low institutional priority. According to Chukwuma and Ibrahim (2025), although sustainability policies exist on paper in many Nigerian universities, practical enforcement is weak, and environmental management is often fragmented across departments. This results in inefficiencies and missed opportunities for integrated

sustainability outcomes. To address these issues, institutions need to adopt a systems-thinking approach, where sustainability goals are mainstreamed into all aspects of governance, curriculum development, campus operations, and community engagement.

Technological innovation also plays a pivotal role in driving environmental sustainability in higher institutions. Smart metering systems, energy-efficient appliances, digital waste tracking platforms, and automated irrigation for green spaces are increasingly being piloted across campuses to reduce resource

wastage and carbon emissions. As documented by Opara and Nwankwo (2024), universities that invest in such innovations not only achieve cost savings but also become more attractive to environmentally conscious students and partners. Additionally, sustainability reporting and environmental audits are essential tools for tracking progress and ensuring accountability. Through consistent monitoring, universities can identify gaps, measure their environmental impact, and make data-driven improvements toward achieving long-term sustainability goals.

Theoretical Framework Systems Theory

(departments, faculties. student bodies. administration) interact with one another and with the external environment. Each unit of the institution contributes to or detracts from sustainability goals depending on its practices. When green management is implemented systemically, it enhances institutional efficiency and ecological performance (Ibrahim & Nwachukwu, 2024). The theory highlights that sustainability outcomes depend not on isolated interventions but on integrated, cross-functional efforts within the institution. For example, digital transformation for waste reduction only becomes effective when supported by infrastructure, training, and policy.

Systems Theory underscores the importance of interconnectedness and feedback loops within the university ecosystem. For instance, when a sustainability policy is introduced by the administrative unit, its success largely depends on how well it is understood, accepted, and implemented by academic departments, facility managers, and student associations. As noted by Okafor and Obi (2024), many sustainability efforts fail not due to poor intent, but due to fragmented

Systems Theory views the university as a complex, interrelated system where various components

execution across units that function in silos. Effective green management therefore requires collaborative planning, communication structures, and monitoring mechanisms that ensure each subsystem aligns with the overarching environmental goals of the university. Moreover, the theory emphasizes adaptability and dynamic response to environmental changes. In the face of climate-related risks, rising utility costs, and increasing regulatory demands, a university must continually evolve its sustainability strategies. According to Edeh and Uchenna (2025), universities in South-East Nigeria that adopt flexible, data-driven approaches—such as using campus-wide energy monitoring systems and adaptive waste separation practices—are better positioned achieve to meaningful environmental outcomes. This Systems adaptability aligns with Theory's proposition that sustainable performance is achieved through continuous learning and institutional evolution.

Finally, Systems Theory supports the integration of sustainability into the core mission of the university—teaching, research, and community service. A systemically sustainable university not

only runs a green campus but also educates students on sustainability, conducts applied environmental research, and partners with local communities for outreach. As shown in the work of Nwosu and Chijioke (2024), when green knowledge is embedded in curricula and cross-departmental sustainability committees are formed, it leads to holistic improvements in environmental performance and a stronger institutional identity around sustainability. Therefore, Systems Theory not only promotes operational efficiency but also encourages cultural transformation within the institution.

Empirical Review

Nwankwo & Ogunlade (2024) found that student-led recycling initiatives led to 30% reduction in landfill waste when backed by university policy. Obi & Ubah (2023) studied solid waste segregation in South-East universities and observed that waste reduction was 45% higher in institutions with on-campus waste sorting centers. Adebayo & Okafor (2023) highlighted that structured recycling programs with departmental green officers increased participation and waste diversion rates. Ede & Ibrahim (2020) emphasized the importance of inclusive recycling committees in promoting long-term behavioral change among staff and students. Udo & Emeka (2016) found poor signage and lack of bins were key reasons for ineffective waste sorting on campuses. Chinedu & Hassan (2013) showed that awareness campaigns alone were insufficient without enforcement mechanisms to boost recycling.

Ike & Ezeani (2024) showed that green curriculum integration led to a measurable increase in proenvironmental behavior among undergraduates. Obinna & Chika (2024) assessed knowledge levels among university staff and discovered a knowledge gap between teaching and non-teaching employees in green practices. Nnadi & Etim (2018) demonstrated that staff with high environmental awareness more actively promoted green policies and contributed to eco-friendly campus practices. Umeh & Yusuf (2014) noted that universities with sustainability embedded in general education courses had significantly better staff and student engagement in green activities.

Musa & Ijeoma (2023) reported that solar panels and smart metering reduced campus energy bills and emissions by up to 35%. Chukwu & Okorie (2022) found that green roofs, motion-sensitive lighting, and systems were key sustainability rainwater investments on successful campuses. Bamidele & Chidiebere (2021) examined the impact of paperless operations and discovered 60% savings on paper use with corresponding carbon footprint reductions. Okeke & Lawal (2018) found composting and use of bio-digesters in university cafeterias significantly contributed to eco-friendly waste reuse. Iwu & Nkemdilim (2013) identified lack of stakeholder buyin as a barrier to implementation of green solutions in several public institutions.

Summary of Related Literature

The reviewed literature has provided rich insights into the various components of green management their role in promoting environmental sustainability in universities. The conceptual review established that green management practices including e-waste handling, recycling, green knowledge acquisition, and green solutions—are critical for reducing the ecological footprint of educational institutions. These practices are increasingly necessary in the face of climate change, rising waste levels, and resource depletion. Regarding green knowledge acquisition, several empirical studies confirm that sustainability education embedded within the curriculum enhances pro-environmental attitudes among students and staff (Ike & Ezeani, 2024; Umeh & Yusuf, 2014). The role of awareness, training, and communication was shown to be indispensable for cultivating a campus culture of sustainability. Additionally, green solutions such as solar energy, smart metering, and water harvesting were found to significantly reduce energy costs and environmental degradation when properly implemented (Musa & Ijeoma, 2023; Chukwu & Okorie, 2022).

The theoretical review anchored the study on Theory Systems Institutional and Theory. Institutional Theory explains how universities respond to external environmental expectations, such as governmental policies and accreditation standards, by adopting sustainable practices. Systems Theory complements this by framing the university as an interconnected structure in which all departments and stakeholders must collaborate for sustainability efforts to be effective. Finally, the empirical review, arranged in descending order (2025-2013), affirms that Nigerian universities have made progress in adopting green practices but are still challenged by weak institutional frameworks, limited funding, and low levels of internal motivation. Most studies recommend integrated approaches, policy support, infrastructural investment, and education as drivers of environmental sustainability in higher institutions.

Research Gap

Although substantial literature exists on green management practices and their relevance to environmental sustainability, significant remain—particularly in the context of Nigerian universities, and more specifically within the South-East geopolitical zone. Most previous studies (e.g., Ogunyemi & Ahmed, 2020; Ezeaku & Obioma, 2017) have focused on broader institutional or urban sustainability without isolating higher education institutions as unique ecosystems. This limits the applicability of findings to the university context, where knowledge generation, youth engagement, and limitations infrastructural present distinctive opportunities and challenges. Another critical gap is

the limited attention to green knowledge acquisition among staff and students. Although education is central to sustainability, few empirical studies have examined how environmental awareness, green curriculum integration, and behavioral change programs influence actual sustainability outcomes on campuses (Ike & Ezeani, 2024). The role of staff engagement and institutional training mechanisms remains underexplored.

Furthermore, existing studies that discuss green solutions like solar panels, digitalization, or smart waste management tend to focus on technical feasibility rather than their measurable environmental outcomes or long-term institutional impact. Very few studies integrate the four variables-e-waste management, recycling/waste reduction, green knowledge acquisition, and green solutions-into a unified framework for evaluating environmental sustainability performance. Finally, the majority of available studies are descriptive or qualitative in nature and do not adopt a comprehensive, data-driven, comparative approach across multiple universities. This study addresses that gap by examining selected universities in South-East Nigeria using quantitative analysis to assess the extent, impact, and interplay of various green management practices on environmental sustainability.

Research Methods

The study adopted a descriptive survey research design. The population of the study comprises all staff and students of selected public and private universities in South-East Nigeria. The universities include:

University of Nigeria, Nsukka (UNN)

Nnamdi Azikiwe University, Awka (UNIZIK)

Federal University of Technology, Owerri (FUTO)

Ebonyi State University (EBSU)

Godfrey Okoye University, Enugu

These institutions were selected due to their size, accessibility, and growing involvement sustainability programs. Within each university, stratified random sampling was used to select participants from both academic staff, non-academic staff, and students. Using the Taro Yamane formula at a 5% level of significance, a total sample size of 400 respondents was determined. Primary data was obtained through a structured questionnaire distributed to staff and students of the selected universities. Secondary data was gathered from institutional sustainability reports, policy documents, and scholarly articles relevant to green management. Data collected were analyzed using the Statistical Package for the Social Sciences (SPSS) version 25.

Data Presentation, Analyses, and Discussion Of Findings Recycling and Waste Reduction

Recycling practices were less prevalent. Waste separation bins were available in 45% of sampled

departments. The mean score was 3.42 (SD = 0.76), showing low to moderate implementation levels.

Green Knowledge Acquisition

Participants agreed that sustainability topics were incorporated into general studies or special seminars. The mean score was 3.74 (SD = 0.69), reflecting moderate to high awareness levels.

Green Solutions

Solar panels, LED lighting, and digital workflows were mentioned in most institutions. The mean score was 3.89 (SD = 0.74), indicating relatively strong adoption of green technologies.

Environmental Sustainability

Overall sustainability performance based on perceptions (e.g., waste volume reduction, energy efficiency) had a mean score of 3.72 (SD = 0.71).

Test of Hypotheses

Hypothesis One (Ho1):

Recycling and waste reduction do not significantly contribute to environmental sustainability.

Pearson correlation (r) = 0.472

p-value = 0.001

Interpretation: Recycling and waste reduction significantly contribute to sustainability.

Hypothesis Two (H₀₂):

Green knowledge acquisition has no significant influence on environmental sustainability.

Pearson correlation (r) = 0.586

p-value = 0.000

Decision: Reject Ho3.

Interpretation: Green knowledge acquisition significantly influences sustainability outcomes.

Hypothesis three (H₀₃):

Green solutions do not have a significant effect on sustainability performance.

Pearson correlation (r) = 0.603

p-value = 0.000 **Decision:** Reject H₀₄.

Interpretation: Green solutions have a significant positive effect on sustainability.

Regression Analysis Summary

A multiple regression analysis was conducted to predict environmental sustainability based on the four predictor variables.

Interpretation: The model explains 62% of the variance in environmental sustainability. All four predictors contribute significantly.

Discussion of Findings

The findings affirm that green management practices—particularly green solutions knowledge acquisition—have significant impacts on environmental sustainability in universities. This aligns with the findings of Ike & Ezeani (2024), who argued that awareness and innovation are pivotal to sustainable campus culture. Furthermore, the importance of e-waste management echoes Uzor & Nwachukwu (2025), who observed that unmanaged e-waste contributes heavily to pollution and resource waste in Nigerian universities. Although some institutions have initiated sustainability programs, the in implementation, inconsistency lack infrastructure, and weak policy enforcement hamper effectiveness. These findings confirm the need for integrated green strategies across all university departments, supporting the systems framework.

Summary of Findings, Conclusion And Recommendations Summary of Findings

This study investigated the impact of green management practices on environmental sustainability in selected universities in South-East Nigeria. It focused on four main variables: e-waste management, recycling and waste reduction, green knowledge acquisition, and green solutions. The key findings from the study are as follows:

- 1. Recycling and waste reduction efforts were less systematically implemented, but still showed a significant contribution to campus sustainability performance.
- Green knowledge acquisition, such as student and staff awareness, curriculum integration, and participation in eco-programs, had a strong and positive influence on environmental sustainability outcomes.
- 3. Green solutions, including digital systems, solar energy, LED lighting, and smart waste practices, had the highest individual impact among the predictors.
- 4. The regression analysis indicated that all four variables jointly accounted for 62% of the variance in environmental sustainability, proving that green management is a critical strategy for ecological performance in universities.

Conclusion

The findings of this study establish that green management practices are essential drivers of environmental sustainability within the university system in South-East Nigeria. The institutionalization of practices such as structured recycling efforts, targeted environmental education, and technological innovations are pivotal to fostering a sustainable learning environment. Green knowledge acquisition, in particular, emerged as a cornerstone for behavioral change and environmental consciousness. Meanwhile, the adoption of green solutions highlighted the universities' growing commitment to operational efficiency and ecological responsibility. However, disparities in practice and policy implementation point to the need for greater institutional alignment, funding support, and enforcement mechanisms.

In conclusion, sustainability in universities must be approached as a coordinated, system-wide initiative. This aligns with the theoretical underpinnings of systems and institutional theory, which advocate for holistic and norm-driven reforms to achieve measurable environmental outcomes.

Recommendations

Based on the research findings, the following recommendations are offered:

- 1. University management should develop and enforce clear policies that integrate all components of green management into strategic planning.
- 2. Separate waste bins, compost systems, and regular training sessions should be institutionalized to improve waste segregation and reduction.
- 3. Environmental sustainability should be embedded into course syllabi, student orientation, and staff development programs.
- 4. Universities should prioritize investment in energy-efficient technologies such as solar power, smart buildings, and digital workflow systems to reduce carbon footprints.
- Regular green audits and sustainability reporting should be adopted to evaluate green practices and ensure continuous improvement.

Contribution to Knowledge

This study contributes to the growing body of literature on sustainability in higher education by:

- 1. Providing a validated empirical model linking green management practices to sustainability performance in Nigerian universities.
- 2. Highlighting the role of green knowledge acquisition as a mediating factor in behavioral change and institutional sustainability.
- 3. Offering new insights on the relative importance of green solutions compared to traditional environmental strategies within the university setting.
- 4. Filling a geographical and institutional research gap by focusing on South-East Nigeria—a region previously underrepresented in sustainability studies.
